- E-mail adress (if given under 'contact' or worldwavedata.com)

Special or sensitive personal data that we process

Svasek has no intention to collect data of people younger than 16 years, unless given permission by parent or guardian. However we cannot control if every visitor to our website is actually 16 years of age. We advise parents and guardians to be involved and monitor the online activities of their children in order to prevent collection of their personal data. If you suspect we have collected data of a minor without such permission, please contact us via leeuwen@svasek.com so that we can remove those data.

Purpose and justification of personal data collection

Automated decision making.

No automated decisions are made based on your personal data that can have significant consequences for your person.

How long do we store data

Svasek Hydraulics keeps your personal data no longer than necessary to realize the stated goals. We use the following retention terms and corresponding reasoning for personal data (business data is herein excluded).

Name > retention period 1 year after last contact > to answer your question

Telephone number > retention period 1 year after last contact > to answer your question

e-mail address > retention period 1 year after last contact > to answer your question or request.

Sharing of personal data with third parties

Svasek Hydraulics will not share your personal data with third parties.

Cookies or comparable techniques

Svasek Hydraulics does not use cookies or comparable techniques.

Seeing, changing or deleting your personal data

You have the right to see, change and delete your personal data. You also have the right to withdraw your permission for use of processing by Svasek, and you have the right to receive those data. You can request all those things via leeuwen@svasek.com. To be sure of your identity (and thus of your claim), be sure to include a copy of a valid ID. Please erase with a black marker on this copy: your portrait photo, the MRZ (machine readable zone), the id number and personal number (e.g. in the Netherlands the Burgerservicenummer or BSN). This in order to protect your privacy. We will react as soon as possible but within 4 weeks to your request.
